PCC's Instructional Services Division, Student Services Division and Planning, Research & Effectiveness all support the plan. It is in its 3<sup>rd</sup> year of implementation. Neil Callahan is the QEP Director.

Completion by Design – In 2011, the Gates Foundation selected four states to participate in a program to enable community colleges to encourage innovative practices that would increase student completion. PCC was a member of the 2<sup>nd</sup> cadre of 26 other NCCCS institutions to participate. PCC's team was provided with key performance indicators on persistence, credit accumulation & completion. In light of these indicators, the team was charged with creating an action plan targeted towards increasing student persistence from one semester to the next with the ultimate goal of credential completion and job placement. PCC's Instructional Services Division, Student Services Division, Planning, Research & Effectiveness and Public Affairs all support the plan. It is in its 2<sup>nd</sup> year of implementation.

Carolina Works – In summer 2015, PCC joined with 9 other NCCCS colleges under the leadership of Central Carolina Community College to apply for a U.S. Department of Education: First in the World validation grant to improve persistence and completion using an individualized success coaching program. The overall goal of this initiative is to increase low persistence and completion outcomes dramatically across 10 NCCCS institutions. "Carolina Works represents the next phase of strategic student success work in a state with strong infrastructure to support scaled reform. PCC's Instructional Services Division, Student Services Division, Planning, Research & Effectiveness and Administrative Services Division all support the plan. It's in its 1st year of implementation, and will be completed in October 2019.
